WE HAVE ALSO WORKED WITH PUBLIC AND PRIVATE PROPERTY OWNERS TO DEVELOP THE TONGUE RIVER WATER TRAIL, A SERIES OF 14 ACCESS SITES ALONG THE TONGUE RIVER AND GOOSE CREEKS TO MAKE IT EASIER FOR PADDLERS AND KAYAKERS TO SAFELY GET ON THE WATER.
